Bill for Alarm Board Passed

Alabama Electronic Security Board of Licensure

To : Companies with late or Non-renewal of Licensure.

From: Alabama Electronic Security Board of Licensure (AESBL)

In accordance with Section 34-1A-7.(f) of the Code of Alabama which established the Alabama Electronic Security Board of Licensure (the Board), the members of the Board have established Alabama Administrative Code 304-X-.03(3) regarding fines for companies performing burglar alarm or locksmith work without a certain license.

All companies, unless exempt by Chapter 1A of Title 34, Code of Alabama 1975, which sell, install, monitor or otherwise operate in the burglar alarm or locksmith business in the State of Alabama must obtain a license from this Board in a timely manner or shall be subject to the following monetary penalties:

•Companies which are currently in the burglar alarm or

locksmith business and do not renew a license by December 31st shall be a new applicant and shall pay all applicable fees.

•Companies which are currently operating in the burglar alarm or locksmith business and do not obtain a license by April 30th, the fine shall be \$500.00 for 2010.

•Companies which are currently operating in the burglar alarm or locksmith business and do not obtain a license by June 30th, the fine shall be \$1000.00 per violation.

If your company is operating in the burglar alarm or locksmith business in Alabama during 2010 without obtaining the proper license from AESBL, please immediately complete the 2010 application process in order to prevent additional monetary penalties.

AESBL Licensing Changes

THE Alarm Board has been working on legislation that would create classifications for licensed companies, which would require the board to propose new rules. They were successful in getting this bill for the 2010 legislation passed today!

Here are a few key items that everyone should be aware of:

AESBL Rules:

- * The current rules require all Burglar Alarm Qualified Agents and Installer/Technicians to demonstrate that they have taken the NTS Electronic Access Control class or the ALOA 2 day Comprehensive Access Control class when renewing for 2011.
- * CCTV Qualified Agents and Installer/Technicians to demonstrate that they have taken the NTS Video System Technology course or board approved training in order to renew for 2012.
- * Effective January 2012 all sales people are required to complete 4 CEU hours on an annual basis.
- * The changes to the law that were passed today expand the definitions in effort to provide clarification on who falls under these requirements. Each type of work is broken into a classification so that licensed companies should not have to take courses when they do not perform such work.
- * Here is a complete breakdown of the changes in the 2010 legislation
- * Definitions added for Central Station, CCTV, and Electronic Access Control System.
- * Establishes classifications for licensing: Locksmith, Burglar Alarm, Electronic Access Control, CCTV, & Central Station. Licensees shall be licensed under appropriate classification in order to perform work in each respective classification.

Since 2011 is when the Comprehensive Access Control Class has to have been taken to renew your license December 2010, we are offering this class several times this year. Instructor: Greg Perry, CML, CPS is a Certified ACE Instructor, a long time member of ALOA and SAVTA and has taught access control and safe lock classes on a local and national basis. **Class Description:** Access control is growing at a rate three times greater than that of standard locks. This is a must course for a locksmith to maintain continual growth and success. This class will consist of a half-day lecture and a day and a half of lab experience of single and multiple door access control systems. Students will learn of the various reader technologies (including smart card), communication formats, operating systems, integration and system designs to name a few. Students will receive handouts and software. **Materials to bring to class:** Small narrow blade screwdriver, wire strippers and voltage ohmmeter. PC Laptop recommended. **Prerequisite:** Students should have an understanding of basic electricity with some PC experience. The information presented will be useful in preparing for PRP section L-40 ALOA members who pay the additional lab fee for the test may take PRP Section L-40 at the end of the second day of class.
